Mr Hughes addressed the Committee on the Regional Council's Forest Lands and Water Collection Areas Interim Management Plan. Mr Hughes referred specifically to section 6.3(2) of the Plan, which required the Council to consider wider values before replanting logged areas.

- (4) *Note that further examination of the concepts and principles raised in this proposal, including the practice of covenanting, will take place within the context of the Long-term Financial Strategy.*
- (5) *Request officers to report back, in the first instance to the Landcare Committee, on the specific issues raised in this paper, and on mechanisms to empower the Council in this area.*

- (4) *Agree that should the Wellington Regional Council take over Whitireia Park, then it would be appropriate to bring it up to the standards and service levels of the Regional Parks Network and that sufficient funding will need to be allocated for this purpose.*
- (5) *Request officers to model the costs for consideration through the Long-term Financial Strategy for the year commencing 2000/01*
- (6) *Note that there are still significant issues to resolve and work through with the Department of Conservation and Whitireia Park Board prior to the Council agreeing to take over the Park.*
- (7) *Agree to the process and programme of work outlined in Table 2 as a basis, should the Council agree to take over Whitireia Park.*
- (8) *Note the opportunities to contribute to key Council objectives and outcomes through maintaining and/or enhancing the values at Whitireia Park, (eg Community and Iwi Connection, Environmental Education and Communication Strategy, RPS implementation, Biodiversity).*
