

*Regional councils*

- 15 **Maximum salaries of chairpersons of regional councils**  
The maximum salary payable under Part IVC of the Act to the chairperson of a regional council is the maximum salary applicable under Part 1 of Schedule 4.
- 16 **Maximum salaries of deputy chairpersons and chairpersons of committees of regional councils**  
The maximum salary payable under Part IVC of the Act to-
- (a) the deputy chairperson of a regional council; or
  - (b) the chairperson of 1 or more committees of a regional council,-
- is the maximum salary applicable under Part 2 of Schedule 4.
- 17 **Maximum salaries of members of regional councils**  
The maximum salary payable under Part IVC of the Act to a member of a regional council is the maximum salary applicable under Part 3 of Schedule 4.

- 18 **One salary only payable**  
The payment by a regional council of the salaries referred to in section 101ZZF of the Act is subject to the condition that the regional council must not pay to a person more than 1 of those salaries.
- 19 **Maximum meeting allowances for members of regional councils**  
The maximum meeting allowance payable under Part IVC of the Act to each member of a regional council (other than its chairperson) is the maximum meeting allowance applicable under Part 4 of Schedule 4.
- 20 **Conditions in relation to payment of meeting allowances to members of regional councils**  
The payment of a meeting allowance to a member of a regional council (other than its chairperson) is subject to the following conditions:
- (a) a meeting allowance is payable by the regional council to a member of the regional council only in respect of a day on which the member of the regional council attends-
    - (i) a meeting of the regional council; or
    - (ii) a meeting of a committee or subcommittee of the regional council where the member of the regional council is a member of the committee or subcommittee or is required to attend the meeting in his or her capacity as a member of the regional council;
  - (b) only 1 meeting allowance is payable by the regional council to a person in respect of any 1 day, even though that person attends more than 1 meeting (being a meeting of the regional council or of a committee or subcommittee of the regional council) on that day;
  - (c) a meeting that continues past midnight otherwise than by adjournment is to be regarded as having concluded before midnight.
