**RSW 73 Presentation – Waitangi Tribunal Claims**

Rebecca O'Brien, Research Officer and Claims Facilitator for the Waitangi Tribunal, attended the meeting and gave an overview of the Wairarapa ki Tararua Inquiry process and summarised specific Wairarapa claims of interest to members.

The Waitangi Tribunal's claims process for Wairarapa during 2003 included the Claimants Final Statement of Claims (February), the Crown's Statement of Response (June), the Tribunal's Statement of Issues (September), with the Hearings scheduled to commence in November/December. Of note was the deadline schedule set out to 2010 for further research and completion of claims under the Tribunal's new approach.

Members commented on the tight timeframe that had been put in place in which the Waitangi Tribunal were expecting to settle the various claims, grievances, and administrative issues.
