Proposal to Reinstate the Rimutaka Incline between Maymorn and Featherston – Presented by Hugh McCracken and Stephen Porter, 25 August 2002

Mr McCracken and Mr Porter gave a presentation on the Rimutaka Incline Heritage Railway Development Proposal and proposed that the next step was to form a working party of interested persons and representatives to prepare a feasibility study for the development.

When asked what the Group wanted from the Wellington Regional Council, Mr McCracken and Mr Porter suggested that the Regional Council could assist the working party with the feasibility study. The Regional Council could also possibly be involved in helping to facilitate the Resource Management and Heritage issues.

A copy of the presentation was circulated.

Following questions Councillor Laidlaw suggested that officers have an informal consultation in-house on the broad parameters of the proposal. Councillor Laidlaw also noted that until Mr McCracken and Mr Porter had presented a formal request Council was unable to determine the degree of support that might be forthcoming from the Regional Council.
