Welcome

Mayor Martin Tankersley, Carterton District Council, said it was his privilege to welcome members and officers of the Regional Land Transport Committee to the offices of the Carterton District Council and the town of Carterton.

Mayor Tankersley said he was pleased to announce that plans were well underway for the Waiohine Bridge replacement on State Highway 2. This will be welcome news to ratepayers.

Mayor Tankersley said there had been a tremendous increase in traffic from Carterton to Masterton and the four laning on the highway linking the two towns would be greatly appreciated. Residents also looked forward to the upgrade of the Rimutaka Hill Road and the replacement of rolling stock on the Masterton to Wellington line.

The Mayor said he trusted the meeting in Carterton would be successful and rewarding for those attending and the residents of the region.

RLT 154 Public Participation**Mr Ian Mellor**

Mr Mellor said he was speaking to Item 4 *The Regional Road Safety Strategy*.

Mr Mellor said there seemed to be inconsistency in the objectives and targets. He questioned using statistics on road deaths and hospitalisation as a measure of crashes.

Mr Mellor also said that choice of mode was a safety issue and noted higher safety returns through travelling on public passenger transport.

These should be covered in the Safety Strategy

Mr Chris Horne, 28 Kaihuia Street, Northland

Mr Horne said he was pleased that most members of the Committee had traveled to the meeting from Wellington by train. The inclement weather was a blessing in disguise as it enabled members to have a first hand experience of the run down nature of the passenger train services between Wellington and Masterton.

Mr Horne said the carbon dioxide emissions continued to increase through growth in the transport sector. Mr Horne asked how would the Regional Land Transport Strategy respond to this.

Mr Horne also commented on Item 5 *The Draft Regional Land Transport Strategy Policies*.

Councillor McDavitt noted with regret that Transit New Zealand and Greater Wellington were the only agencies that had presented reports for today's meeting.

Urban Rail Report - The Draft Contract

Dr Watson said that Toll Rail had responded to Greater Wellington's Contract document. The Greater Wellington working group should have completed its evaluation of the Toll Rail response in 3 to 4 week's time. Then the contract negotiation between Greater Wellington and Toll Rail will begin in earnest.

Business Plan

Dr Watson said preparation of the Business Plan which will eventually form part of the final contract was a huge undertaking involving all infrastructure projects, rolling stock and major track improvements.

The consequence will be a change to the Long Term Council Community Plan (LTCCP) and there will therefore be the need for a full community consultation. Dr Watson said he expected this consultation to begin in March 2005.

Future Funding of Rail

Dr Watson said Greater Wellington was involved in ongoing discussions with Government. The conclusion of these negotiations will be fed into the consultation with the regional community next year.

Last Meeting of Triennium

Councillor McDavitt thanked members for the good work that had been achieved during the past three years. Councillor McDavitt said that while the work sometimes could be burdensome there had been some very good rewards and he hoped to see many of the persons sitting around the table in the next triennium.

Mayor John Read , South Wairarapa District Council

Councillor McDavitt said that Mayor Read had decided not to stand again for the Mayoralty of the South Wairarapa District Council and thanked Mayor Read for his contribution to transport during the past 20 years. Councillor McDavitt noted that Mayor Read was today attending his last meeting of the Committee.

Mayor Read said he had been involved in transport matters from the beginning of his political career. There had been a change in emphasis over the years and he believed that local government and central government were now probably heading in the right direction by concentrating on regional transport strategies.

Mayor Read thought that the possibility of positive outcomes for the greater good looked more likely but at the same time there was still a fair amount of wishful thinking amongst some politicians.

Mayor Read said he was confident that the rural sector will be well represented in the future and noted that commerce starts in the farming community in areas such as Glenburn. It was always important to note the economic impacts of transport decisions on the regional economy.

Mayor Read said he had been associated with some wonderful people on the Transport Committee, thanked everyone for putting up with him and wished all members a good time in the future.

The Committee showed its appreciation by **acclamation**.
