Mr Barry Jenness, Resident, Hathaway Avenue, Lower Hutt

Mr Jenness representing the residents of Hathaway Avenue tabled, and spoke to, a paper regarding the draft project implementation sequence for the capital works programme 2006 - 2016 for the Hutt River. He particularly urged that work begin on the Hutt/Boulcott stopbank as early as possible.

Hutt Golf Club

Mr Rod Gillespie representing the Hutt Golf Club spoke on similar lines to Mr Jenness. The Club supports increased dredging and the building of a stop bank as soon as possible. The Golf Club would prefer that river bed levels be reduced as low as possible below the 1998 levels.
