Mai Chen is a founding partner of Chen Palmer & Partners, Australasia's first public law specialist firm. He has also served as Chairman of Maori Rugby League and Aotearoa Maori Sports Federation. In his first term of Parliament Mr Tamihere was Chairman of the Maori Affairs Select Committee and was a Member of the Finance and Expenditure Select Committee. He was re-elected in the newly formed Tairāhema Makaurau seat in 2002 with 72 per cent of the vote, and was appointed to Cabinet that year. He holds arts and law degrees from The University of Auckland.

Nicholas Low is associate professor in environmental planning at the University of Melbourne, Australia. Nicolas has published widely on planning, environmental ethics and eco-politics. His 1998 book co-authored with Brendan Gleeson, Justice, Society and Nature won the Sprout Award for eco-politics from the International Studies Association. Recent work includes three edited collections: Consuming Cities, Global Ethics and Environment, and Governing for the Environment. He published Australian Urban Planning with Brendan Gleeson which won a national award from the Royal Australian Planning Institute for 'planning scholarship' and he is now working on two books, one on 'sustainable transport' for Palgrave (UK) and one on 'The Green City' for UNSW Press. His current research focuses on long term social change, paradigm shift and 'ecosocialisation' with particular focus on transport systems.

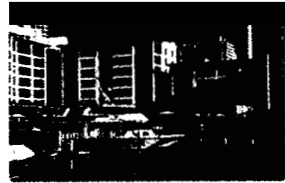

This tour provides an overview of the revitalisation of the Auckland waterfront, from the concept planning through to the development of the waterfront area. Stopping at key points including:

- .Britomart - an integrated transport interchange as well as a partnership between Council and a developer to revitalise a 5 hectare heritage precinct, the largest mixed-use heritage restoration project ever undertaken in New Zealand.

- .Pier One - new downtown ferry terminal

- Viaduct Harbour - mixed use development of a former industrial area

- Auckland Fish Market - an innovative development providing a centre of commerce for the seafood industry, as well as a retail and tourism attraction including a seafood cookery school, retail area, eateries and other outlets.

ST 2 - Culture & Diversity

If you want to buy a lava-lava, jostle amongst people of different nationalities, purchase designer sunglasses and watches made in China (which you might haggle for), eat curry while listening to Pasifika flavour hip-hop - then this is the trip for you. We live in a stunningly diverse place and we invite you to come along on an exciting journey. We will take you to Otara Market, where you can shop and bob, then wind our way through East Tamaki and Botany where we pause at locations where culture has made a contributing statement on the urbanscape. Arrive at bustling Howick/ Botany, a popular fast growing suburb of Manukau where many Asians chose to live. A place of Chinese noodle bars, Asian commodity mini-marts, gift shops stocked with items made outside of NZ and subtle influences of feng shui in the layout / design, colours and construction of the houses and outdoor space.

ST 3 - Energy

This tour will investigate the environmental and planning issues associated with the generation and transmission of energy. Departing Sky City at 9:45am, the group will travel to Huntly for tours inside the Rotowaro opencast coal mine and the Huntly Power Station, New Zealand's largest thermal power station. The tour will also look at renewable energy sources, including a case study of a solar-powered service station. During the journey to and from Auckland there will be a discussion of the planning and environmental issues associated with one of New Zealand's largest infrastructure projects - Transpower's North Island Lines Upgrade.

ST 4 - Hauraki Gulf Islands

This tour will explore the islands of the Hauraki Gulf by boat, looking at heritage and coastal planning issues, iwi planning initiatives, and the development and protection of the islands and environment of the Hauraki Gulf. The tour will visit Pakihi and Ponui Islands, Man 'O' War Bay, Waiheke Island, & Rangitoto Island. Walking shoes are a necessity.

ST 5 - Matakana and Omaha

This study tour will visit the fast-growing rural and coastal communities of the Matakana / Omaha area, on the coastal edge north of Auckland. After setting the scene with an overview of the Matakana Structure Plan and the Vision Rodney Plan, the tour will look at the challenges facing the wine industry in Matakana, and take in lunch at one of the vineyards. Following lunch, the tour will head for the coast to look at coastal development issues at Omaha Beach and the issues that this has posed for tangata whenua. We will end the day with a final stop in at another one of the Matakana wineries for wine tasting before heading back to Auckland.

ST 6 - North Shore

A short ferry trip to Devonport starts a heritage walk and a discussion on heritage protection in North Shore, including Maori heritage at North Head. The tour will then visit the Devonport Naval Base to learn about NZ Defence's significant and historic connection with Devonport, and the planning issues associated with the naval base.

The study tour will also look at coastal issues along the North Shore coast from Devonport to Milford, including coastal development pressures, strategic land purchases and the protection of natural heritage features such as a fossil forest and sacred pohutukawa grove. The tour will conclude with a visit to Lake Pupuke, a popular recreational lake formed within an old volcanic explosion crater.

ST 7 - Rodney's West Coast Communities

This tour will explore the rural and coastal areas on the western edge of the Rodney District, north-west of Auckland. The tour will provide the opportunity to learn about sustainable agriculture at an organic farm overlooking the Kaipara Harbour. The tour will then visit Helensville to hear about the community planning initiatives that are currently underway in Rodney District. This will be followed by a visit to the wild west coast at Muriwai to look at the planning and land management issues in this sensitive environment particularly relating to the Muriwai Regional Park.

ST 8 - The Effects of Infrastructure & Growth

This tour studies environmental interactions between rapid urban growth and two major infrastructural projects - the Mangere Wastewater Treatment Plant and Auckland International Airport. Highlights include touring the wastewater treatment plant and associated beach restoration projects, commentary on historic stonefields and presentations on the future development of the airport, including integrated transport, a second runway, noise, residential growth, business parks and stormwater treatment issues.

ST 9 - Tiritiri Matangi Island

Tiritiri Matangi is an Auckland island sanctuary that provides a pest-free habitat for a number of rare and endangered species including saddleback, takahe North Island robin, kokako, little spotted kiwi and stitchbird. It is one of the most successful conservation projects in the world. Unwanted predators have been eradicated, and the once-pastoral island has been replanted with native trees.

This study tour will allow you to explore the island on a guided walk as well as hear from speakers with a great depth of knowledge about the island and its bird life. The study tour will also include some discussion of predator control and recent initiatives to develop mainland islands. Bring wet weather gear and sturdy shoes.
