- Chris Horne told the Committee that he feels that the building of a new road is not the solution to Western Corridor road traffic congestion. He maintains that a better solution is to upgrade the railway line and services.
- Adrian Webster spoke on behalf of the Transmission Gully Action Group which favours the Transmission Gully Motorway option. The group considers that the Subcommittee's report contains all the information the Committee needs to make a robust decision. The group urges the Committee to move forward as quickly as possible
- Barry Cook supported and applauded the Subcommittee's report. He asks the Wellington region to back the proposal to proceed with the Transmission Gully Motorway option

- Paula Warren favours the rail option over road for the solution to Western Corridor road traffic congestion. She rejects part of the report, and feels that it defers the Waikanae problem. Ms Warren asked for a more balanced package for Western Corridor passenger transport.
