**Adrian Webster**, on behalf of the Transmission Gully Action Group, expressed concern about the lack of firm undertaking by Transit NZ to construct minor traffic works on the Kapiti coast, particularly those associated with the McKay’s crossing overbridge. He sought the Committee’s assistance in ascertaining what Transit NZ’s intentions are.

**Chris Horne** recommended that the second draft of the Wellington RLTS 2007 be revised — taking into account climate change and need for greater utilisation of public transport. He also advocated using the money allocated to the Transmission Gully motorway for building a double-track rail tunnel between Pukerua Bay and Paekakariki, and double-tracking the line northwards.

**John Vannisselroy** urged that tight curves in the railway line between the Horokiwi and Petone stations be eased in association with works planned to extend the Ngauranga to Petone Cycleway.

Mr Vannisselroy also advocated either the building of an “overtaking track”, or reinstating the Melling – Manor park line to make the targeted 10 minute train frequency on the Hutt Valley line achievable.

**Brent Keith**, on behalf of the Rail and Maritime Transport Union, again told the Committee that he felt that Tranz Metro’s service is being compromised by the unreliability and shortage of rolling stock. He also reported that increased reliability demands the removal of choke points along the lines, the design of realistic timetables, and the independence of lines. Mr Keith also expressed disappointment that his union and Ontrack had not been invited to participate in the Ngauranga to airport problem framing study.

**Paula Warren**, on behalf of Transport 2000+ discussed the role of transport modes. She maintains that the document for consultation should specify what the modes are, and how progress will be made. Ms Warren feels that the RLTS should be more ambitious.
