**Brent Efford** welcomed the new committee, and emphasised the challenges to the transport industry presented by climate change. He lauded the items listed on the agenda for discussion, and urged the committee to “go for it”.

**Chris Horne** supported the introduction of real time information and integrated ticketing as improvements to the transport system which will encourage greater use. He welcomed the introduction of new EMUs and the planned upgrade to some of the rail infrastructure on the Wellington-Paraparaumu line, but felt that further improvements could be made.

**Paula Warren** urged the Committee to work in a vigorous, innovative fashion to provide the citizens of Wellington with a quality transport system which will discourage car use and reduce the impact on the environment.

**Pete Wilson** and **Brent South** of the Accessible Transport Action Committee (ATAC) expressed support for the Real Time Information System, and advocated the introduction of extra features such as disabled-friendly and multilingual display. They noted that ATAC is keen to build an ongoing relationship with GWRC.

**Councillor Wilson** tabled a petition on behalf of 25 Paekakariki residents in support of the Otaihanga Shopper Route 78 bus service.
