1. <u>APOLOGIES</u>

2. <u>PUBLIC COMMENT</u>

There were no speakers under public comment.

3. <u>MINUTES</u>

4. <u>WAIWHETU STREAM FLOODPLAIN MANAGEMENT STUDY LOWER</u> <u>WAIWHETU PRELIMINARY DESIGN REPORT</u> (N/03/21/01/RM50-15-11)

Report No. WSAC2006/4/1 by the Project Manager – circulated pages 1 – 4.

The Project Manager introduced the report, and Mr Easther made a presentation on the preliminary design, highlighting that economic considerations support the continuation of the preliminary design concept. He commented on proposals for each reach of the stream and noted that, as part of the development of a comprehensive floodplain management plan, the situation whereby the stream continues to be confined should be avoided, and this is one of the reasons why Option 3 is supported.

Responding to questions from members, Mr Easther commented on provision made for services that cross the stream, including costings included for siphons where the sewer needs to be lowered, adding that siphons are not widely supported. He commented on resource consent, designation and land acquisition issues and timing, and expressed a preference for development of a floodway that does not require physical works. He outlined the risks associated with the project and mitigation measures proposed.

- (iv) notes that a final decision to adopt Option 3, or otherwise, should be made at the conclusion of Phase 2 studies (to be completed in June 2007) so that the mix of structural and non structural flood mitigation solutions can be considered as a whole, before completing the Waiwhetu Stream Floodplain Management Plan."

Responding to questions from members, the Divisional Manager Catchment Management confirmed that officers could develop scenarios based on a 6 year and 10 year timeframe for the project but noted that there was uncertainty about when these timeframes could apply from.

5. <u>WAIWHETU STREAM FLOODPLAIN MANAGEMENT STUDY</u> <u>AWAMUTU PRELIMINARY DESIGN REPORT</u> (N/03/21/01/RM50-15-11)

Report No WSAC2006/4/2 by the Project Manager – circulated pages 5 – 8.

The Project Manager introduced the report, and Mr Fountain made a presentation on the preliminary design and summarised the costs involved, which are less than estimated at the options assessment stage and now provide for a 100 year return period level of protection rather than 50 years.

Responding to questions from members, Mr Fountain confirmed that final design would follow the consent process, and that the floodgate completes the flood defences against the Waiwhetu Stream and the pump station is an essential component of the Awamutu Stream project. He confirmed that the hydraulic modelling undertaken takes into account the effect of the Waiwhetu Stream on the Awamutu Stream.

- (v) notes that a final decision to adopt Option 3, or otherwise, should be made at the conclusion of Phase 2 studies (to be completed in June 2007) so that the mix of structural and non structural flood mitigation solutions can be considered as a whole, before completing the Waiwhetu Stream Floodplain Management Strategy; and
- (vi) requests an indicative schedule of works to best fit in with the Waiwhetu Stream 6 year and 10 year options."

6. <u>WAIWHETU STREAM FLOODPLAIN MANAGEMENT STUDY:</u> <u>CONTAMINATED SEDIMENTS REMEDIATION UPDATE</u> (N/03/21/01/RM50-15-11)

Report No. WSAC2006/4/3 by the Biodiversity Coordinator Environmental Policy – circulated pages 9 – 12.

The Biodiversity Coordinator introduced the report and advised that the Ministry for the Environment has indicated it would be interested in receiving a proposal for a remediation plan, and that the required funding may be available.

7. ONGOING CONTAMINATION OF THE LOWER WAIWHETU STREAM

Report No. WSAC2006/4/4 by the Divisional Manager Utility Services – circulated pages 13 – 20.

The Divisional Manager Utility Services introduced the report and elaborated on the monitoring proposed and the current discussions taking place between officers of the two councils aimed at streamlining processes where contamination is discovered and empowering Hutt City Council staff to take action when required.

Members expressed concern over difficulties associated with enforcement, particularly in respect of those operators who repeatedly make illegal discharges.

- *(iii)* requests a report back to the next meeting on options for enforcement against polluters."

8. <u>WAIWHETU STREAM FLOODPLAIN MANAGEMENT STUDY</u> <u>PROJECT MANAGER'S REPORT</u>

The Project Manager elaborated on the report and advised that a further public meeting is scheduled for 7 October 2006.
