*(1) Real Time Information*

*The information in this report relates to the Real Time Information project. Release of this information would disadvantage the Council in its negotiations with potential providers as it would reveal Greater Wellington's negotiation strategy. Greater Wellington has not been able to identify a public interest favouring disclosure of this particular information in public proceedings of the meeting that would override this prejudice.*

*That the public conduct of the whole or the relevant part of the proceedings of the meeting would be likely to result in the disclosure of information for which good reason for withholding would exist under section 7(2)(h) of the Local Government Official Information and Meetings Act 1987 (i.e. to enable Greater Wellington to carry out, without prejudice or disadvantage, commercial activities).*

*(2) Allows Mr Bill Inglis of Audit New Zealand to remain this meeting after the public has been excluded, because of his knowledge of the real time information tender process. This knowledge, which will be of assistance in relation to the matter to be discussed, is relevant to that matter because the Council will be discussing the tender process.*
