Request for information 2022-065

I refer to your request for information dated 18 May 2022, which was received by Greater Wellington Regional Council (Greater Wellington) on 18 May 2022. You have requested the following:

- "1. Please send me meeting and event attendance records for all councillors this triennium. Please include all full council and council committee meetings, all councillor workshops, and all official field trips or events (if such information is available).
- 2. Please send a spreadsheet showing all councillor's remuneration and personal expenses this triennium. I anticipate this would include base rem, additional rem for roles like committee chair, travel and other expense reimbursement. No detail required at this stage, just a table of totals broken down by councillor, spend type and financial year (including YTD for 2021-22, and updated totals once FY ends)."

Greater Wellington's response follows:

1. Please send me meeting and event attendance records for all councillors this triennium. Please include all full council and council committee meetings, all councillor workshops, and all official field trips or events (if such information is available).

Council and committee meetings

Councillor attendance is recorded in the minutes of each Council, committee and subcommittee meeting. We are, therefore, refusing this part of your request under section 17(d) of the Local Government Official Information and Meetings Act 1987 (the Act) on the ground that requested information is publicly available.

Councillor workshops

Greater Wellington has implemented a formal process to document attendance at workshops from 28 October 2021. Attendance information prior to this date has not been documented or kept. It is therefore necessary to refuse your request for the period from 12 October 2019 to 27 October 2021 under section 17(e) of the Act on the ground that the document alleged to contain the information does not exist or, despite reasonable efforts to locate it, cannot be found.

Please refer to Attachment 1 for councillor attendance at workshops from 28 October 2021.

Field Trips

Field trips for Councillors are organised to provide Councillors with a better understanding of Greater Wellington operations and matters of local interest. This triennium, field trips have included visits to the following:

- Locations along the Hutt River (for flood protection, with Hutt City Councillors invited),
- · Wainuiwhenua, for climate change,
- Various locations in the Wairarapa for environment and transport related reasons
- Various locations across the Metlink bus and rail network.

Field trips are arranged by the relevant Greater Wellington departments and Councillor attendance has not been recorded. As such, it is necessary to refuse this part of your request under section 17(e) of the Act on the ground that the document alleged to contain the information does not exist or, despite reasonable efforts to locate it, cannot be found.

Events

Greater Wellington does not record Councillor attendance at events, as Councillors are invited to a variety of events that are not organised by Greater Wellington. Councillors also manage their own diaries. We have, therefore, refused this part of your response under section 17(e) of the Act on the ground that the document alleged to contain the information does not exist or, despite reasonable efforts to locate it, cannot be found.

Where we have refused your request under section 17(e) of the Act, we are required to consider consulting you. In this instance we do not consider that consulting you would change the outcome of our decision.

2. Please send a spreadsheet showing all councillor's remuneration and personal expenses this triennium. I anticipate this would include base rem, additional rem for roles like committee chair,

travel and other expense reimbursement. No detail required at this stage, just a table of totals broken down by councillor, spend type and financial year (including YTD for 2021-22, and updated totals once FY ends).

The Remuneration Authority is responsible for determining the remuneration of local authority elected members, and it issues a publicly available determination each financial year, and whenever a council changes its remuneration structure.
