- 5. The Council is interested in the relief sought by Waikanae North in relation to certain Climate Change provisions, specifically:
 - (a) Policy CC.2;
 - (b) Policy CC.2A;
 - (c) Policy CC.8;
 - (d) Policy CC.9; and
 - (e) Policy CC.11.

6. The Council opposes the relief sought in relation to Policies CC.2,

CC.2A, CC.8 and CC.9 as, despite the amendments, these policies

still impose requirements on territorial authorities which are

outside the functions and responsibilities of territorial authorities

under the RMA.

7. The Council supports the deletion of Policy CC.11 as this policy will

impose unnecessary costs onto territorial authorities in relation to

transport infrastructure applications without delivering tangible

greenhouse gas reduction benefits.

Mediation

8. The Council agrees to participate in mediation or other

alternative dispute resolution of the proceedings.
